International Agreements and Distinctions

Double Taxation Agreements (DTA): Mauritius has signed 46 DTAs with countries such as France, India, the UK and China, avoiding double taxation on income and capital gains and making it easier to repatriate funds without facing excessive taxation.

Trade Agreements: Mauritius is a member of several trade blocs, including COMESA (Common Market for Eastern and Southern Africa) and SADC (Southern African Development Community), providing privileged access to various regional markets.


